

Greetings in the name of the Royal Martyr—

All Saints' Day is celebrated on 1 November by parts of Western Christianity, and on the first Sunday after Pentecost in Eastern Christianity, in honor of all the saints, known and unknown, in heaven and on earth.

In many Anglican churches and in the Roman Catholic Church, the following day, **All Souls' Day**, specifically commemorates the departed faithful who have not yet been purified and reached heaven. Christians who celebrate All Saints' Day and All Souls' Day do so in the fundamental belief that there is a prayerful spiritual bond between those in purgatory (the "Church expectant"), those in heaven (the "Church triumphant"), and the living (the "Church militant"). Thus, we pray for the happy repose of the souls of our members who have departed this life during the past 12 months: The Rev'd Kent Lambert Haley, Ben., of Keizer, OR (HONORARY MEMBER) ... The Rev'd Frederick Shepherd Thomas, SSC, OL, of Baltimore, MD (HONORARY MEMBER)... The Rev'd Elijah Brockenbrough White III, Ben., of Leesburg, VA (LIFE MEMBER)... Ransom H. Widner, of Providence, RI.



Today, we specifically commemorate the death on this day in 1612 of Prince Henry Frederick, resulting in **Prince Charles becoming heir apparent** to the British throne. Prince Henry died of typhoid fever at age 18. In the United States, two places in what was then the Virginia Colony, Cape Henry and Henrico County, were named after him. Four years after the death of his older brother, Prince Charles was created Prince of Wales and Earl of Chester.

# **HISTORY**

The Society of King Charles the Martyr is one of the several devotional societies initiated by Anglo-Catholics in the 19<sup>th</sup> century. It was founded in London on Easter Tuesday, 1894, by a scholarly Scots lady, Ermengarda Greville-Nugent (the Hon. Mrs. Patrick) together with the rector of Saint Margaret Pattens. In the Americas, the Society was active already in 1894 in New York, under the leadership of the Rev'd William Harman van Allen, later rector of the Church of the Advent, Boston (1902-27), and has remained active here since that time.

Charles was regarded as a martyr for the Church and for the people already at the time of his beheading, and after Church and Crown were restored in 1660 the Convocations of Canterbury and York, meeting jointly, adopted service for 30 January in 1661. In its prayers, King Charles was called a Saint and a Martyr.

In recent years, Royal Martyr Day has achieved greater recognition in North America. In 2015, the General Convention of The Episcopal Church took initial action to add this observance to the church calendar. The commemoration is also on the kalendar of the Anglican Church of Canada, the Anglican Church in North America, most jurisdictions in the Anglican Continuum, and Common Worship in the Church of England.

Today, all Christians enjoying the patronage of King Charles the Martyr may become members of the Society, a U.S. tax-exempt organization not formally affiliated with any ecclesiastical entity.

"For this is thankworthy, if a man for conscience toward God endure grief, suffering wrongfully. For what glory is it, if, when ye be buffeted for your faults, ye shall take it patiently? but if, when ye do well, and suffer for it, ye take it patiently, this is acceptable with God.
