

The Question of Authority: Picking Up What is Broken

hen the Solicitor-General, John Cooke, started to read the charge against King Charles, the king tapped him on the shoulder with this cane accompanied by the command, "Hold!" followed by a second poke. Cooke ignored the command and continued. The third time, the King poked him with enough force that the silver tip came off and rolled on the floor.



King Charles wanted to know by what authority he had been called. His voice was not being heard and used the tip of his cane to get the attention of the man prosecuting him. Dramatically, the cane proved impotent, falling apart as if to symbolize the future of the monarchy and its arguments for authority. When the tip rolled on the floor, no one picked it up. The King himself had to rise and retrieve the tip and place it in his pocket.

How very often we feel that our voice isn't being heard. Both the Church and Culture keep speaking despite our pleas to *hold*. We plead for an explanation for the authority that grants a license to actions. The State Services were removed in 1859 (see Dr Roman's excellent article), the Royal Martyr is still absent from the American Prayer Book, and so often the martyrdom of King Charles is misunderstood. The proverbial tip of our cane falls off and rolls on the floor.

We pick it up.

We remember that King Charles returned to his trial with the tip restored. He continued to prod and to raise the question of authority. He held to the conviction of Apostolic Faith and Order. His perseverance brings us to our persistence. May we use the Feast of the King Charles the Martyr as a call to renew our commitment to Our Lord and His Church and to continue our patient and persistent call to examine the question of Authority. And when our efforts are derided, ignored, or broken, let us rise and pick up what is broken and return to our trial restored. Remember!

When Cross and Crown Conflict: The Order of 1859

n January 17th1859, Queen Victoria issued an order to cancel the State Services in the Book of Common Prayer that marked the Commemoration of King Charles the Martyr on January 30th.

This order raises important questions concerning the relation between Church and State. But, more significantly, it also has an enduring relevance for all members of the Society of King Charles the



Martyr since our Society's foundational basis has ever been to oppose, on a number of fronts, the regrettable consequences that this order produced in the life of Ecclesia Anglicana since.

Indeed, January 17th might well be called a day of mourning, second only to the actual Feast of the Martyrdom of Saint Charles. It likewise constitutes a clarion call to us to redouble our efforts aimed at restoring justice with respect to the honour of the Royal Martyr who, on January 17th, suffered another blow, this time a legislative one to his enduring legacy as the defender and protector of the Church for which he died.

The entire issue is replete with the paradigm of Church-State relations. It would not be the first time in Christian history that this occurred. The two-headed eagle of the Byzantine, Russian and other empires testified to a synergy between Church and State. Byzantine Emperors called together Ecumenical Councils, when needed, to settle disputes regarding matters of faith and church discipline. Twenty such emperors and empresses were canonized for their services to the Church in this regard.

And when Tsar Saint Nicholas Romanov and the Royal Family of Russia were targeted by the Bolsheviks on July 17, 1918, they were martyred precisely because they represented the unshakeable synergy of the Orthodox Church and the Orthodox State with whose continued survival the Bolsheviks had no hope of inaugurating their new atheistic world order founded on the enslavement and destruction of many millions of people.

Saint Charles, King and Martyr, stands in that same historic Christian tradition where the Church was to Christianize society and bring to fruition the highest ideals of civil government founded upon Biblical norms and values.

He did that, first and foremost, by defending the same Catholicity of the Church which he clearly saw as continuing from the ancient Orthodox and Catholic Church of Jesus Christ down to his own "Orthodox Church of England" as he himself called it, complete with Apostolic Orders and Catholic Authority while blossoming with her own Saints, Doctors and Martyrs as testimony to its own true ecclesial reality and validity.

The 1859 Order was, in the words of the Anglo-Catholic liturgist, the Very Reverend Vernon Staley, "...clearly ultra vires ... to make the action of the Queen and the Parliament in 1859, in cancelling the form for January 30, valid, it is necessary to show that Convocation assented to the discontinuance of that form of Service. No evidence of Convocation being consulted as to the discontinuance of the Service is so far forthcoming ... If so, the question will arise whether the Crown had the right to this action apart from the acquiescence of Convocation. To this question there can be but one answer, and that is in an emphatic, NO." (Liturgical Studies, 1907, pp. 77-78).

To oppose the order of January 17th, 1859 by promoting the liturgical and private veneration of King Charles the Martyr is not to be engaged in some sort of quaint hearkening back to times largely irrelevant to contemporary modernity. In fact, quite the opposite is true.

The promotion of the celebration of St Charles in accordance with the historic Common Prayer Services affirms, at the same time, the independence of the Church from the State whenever the latter attempts to constrict its life so as to unduly and negatively influence its role as a true Christian leaven for society and the world.



When it comes to its Orthodox faith, Catholic sacraments and Evangelical preaching – the Church will not be silenced! The heretics of old found that out and so have the modern communist states. The modern materialistic, secular society with its own brand of anti-Christian a priori will likewise learn its lesson in a similar manner.

So on this day let us all rekindle our Apostolic zeal and redouble our efforts at promoting the liturgical celebration of King Charles the Martyr as our own contemporary witness to the Christian values he espoused which, as they were at the time of the Apostles and throughout the Church's history, part of the great commission given to us all by our "Great God and Saviour, Jesus

Christ." May we, by the intercession of the Royal Martyr, be empowered by the Holy Spirit to fulfill this our great duty and responsibility! Let us begin now to prepare ourselves for the upcoming Feast of St Charles so that we may truly and worthily "Remember!"

Some Caroline Snippets

he BBC reminds us of **one good reason that the Cromwells were removed and our Mother Country returned to its senses:** Lord Protector of England Oliver Cromwell seemed to be the Grinch of the 1600s. With the assistance of Parliament, he passed an ordinance in June 1647 that banned celebrating



Christmas. The notoriously puritanical Cromwell viewed elaborate Christmas festivities as wasteful, overly decadent, and sinful practices that threatened what he thought were the foundations of Christianity. The ban was strictly enforced, so much so that shops were to remain open on Christmas Day and soldiers patrolled the streets of London. They were ordered to confiscate any Christmas-related celebration food or decoration. The ordinance also abolished Easter and Whitsun feasts. Any indication of celebrating such a holiday could lead to an arrest. The ban (along with other legislation) was overturned in 1660 when the English Restoration took place. Don't forget that the Friends of the SKCM Group in Facebook is a membership benefit!
